CFL, players' union at odds regarding payment of off-season bonuses

The CFL has drawn the ire of the CFL Players' Association by directing its teams to stop paying players off-season bonuses until a new collective bargaining agreement is reached next year, a tactic the union says has driven a wedge between the two sides before contract

talks have even begun.

Many CFL players now receive upfront money, in the form of either a signing or roster bonus, as part of their contracts. But the league has directed clubs to refrain from doing so this offseason until after a new agreement is ratified.

The current deal expires May 15, 2019. Players can sign contracts this offseason but won't receive any signing

bonuses until after a new CBA is reached.

"I think everyone agrees we're looking for a fair agreement at the next bargaining session for everybody but this widens that gap prior to even sitting down," said Brian Ramsay, executive director of the CFLPA. "If the thought process is it's meant to speed up or assist bargaining, we vehemently disagree with that.'

Former commissioner Jeffrey Orridge issued the directive in early 2017 and it's since been supported his successor Randy Ambrosie. A former CFL player and CFLPA secretary, Ambrosie has worked closely with the union since his appointment last summer and in September the two sides agreed to eliminate in-season full contact padded practices and move to a longer, 21-week schedule to enhance player safety.

- Outside water taps and underground sprinkler systems should have the water supply shut off inside the house at the isolation valve for the tap.
- Sprinkler lines and taps should be drained/blown out.
- A thin stream of water (as thick as a pencil lead) running continuously from at least one tap will help prevent a frozen
- If you plan to be away from home over the winter period, close the main water isolation valve located next to the water meter in your home. You should leave the heat on in your home and have someone check inside your home daily while you're away.

A frozen water service, or a burst water pipe, is an inconvenience and expense that most people would like to avoid. Please take all possible precautions to prevent this happening in your home or business.

New England Patriots quarterback Tom Brady returned to full practice nine days before the Super Bowl, but tight end Rob Gronkowski is still recovering from a concussion.

In the injury report issued on Friday, the team said neither Gronkowski nor defensive lineman Deatrich Wise would play if the game were this Sunday. With the extra week off before the Super Bowl against the Philadelphia Eagles, however, there is still time.

Brady required stitches in his right hand and thumb after an injury in practice last week. After missing parts of practice leading up to the AFC championship, he started in the game against the Jacksonville Jaguars and led New England to a 24-20 victory.

Defensive lineman Malcom Brown (foot) also missed practice on Friday for the second straight day. Offensive lineman LaAdrian Waddle and running back Mike Gillislee missed part of practice for the third day in a

Canada's Anderson wins gold in parallel giant slalom at snowboard World Cup

Canadian snowboarder Jasey-Jay Anderson won a gold medal in parallel giant slalom on Friday, becoming the oldest rider to win a World Cup.

The 42-year-old, who was named to Canada's Olympic team on Thursday, edged World Cup leader Nevin Galmarini of Switzerland for his 28th career win in his 257th start on the World Cup circuit.

Italy's Edwin Coratti won the small final for

"I didn't know that I still have the legs for this but I guess I still do," Anderson said in a release. "Now, with the boards finally getting better, I'm looking forward to the Olympics and something big."

Anderson, a four-time world champion from Mont-Tremblant, Que., will be competing in his sixth Olympic Games next month. He's the only rider to compete in every Olympics since snowboarding made its debut

Anderson won gold in parallel giant slalom at the Vancouver Games in 2010.
