ATTENTION: UTILITY CUSTOMERS NOTICE OF PROPOSED RATE CHANGES

On Monday, December 2, 2019 City Council gave first reading to the following:

BYLAW #4609 to amend Bylaw #2379, the Water Service Bylaw by amending certain rates, fees and charges; and

BYLAW #4610 to amend Bylaw #1541, regulating the use of Public and Private Sewers and Drains and the Disposal of Sewage and the Discharge of Waters and Waste into the City's Sewer System; and

BYLAW #4611 to amend Bylaw #1805, the Waste Bylaw by amending rates and charges; and

BYLAW #4612 to amend Bylaw #2489, the Gas Utility Bylaw by amending certain rates, fees and charges; and

BYLAW #4613 to amend Bylaw #2244, the Electric Utility Bylaw by adjusting certain non-commodity rates charged for electric energy distribution service to residential, commercial and industrial customers of the City's Electric Utility.

The proposed Bylaws will come into force on January 1, 2020.

A Non-Statutory Public Hearing in general accordance with the Municipal Government Act and the City's Procedure Bylaw, and consideration of the Second/Third Readings of the proposed Bylaws will be held in the City Hall Council Chambers at the address below on Monday, December 16, 2019 beginning at approximately 6:30 p.m.

Any person who claims to be affected by any of the proposed bylaws may make representation to City Council at the Non-Statutory Public Hearings. Oral submissions are limited to five minutes.
