#### CART COLLECTION TIPS

- Carts must be out by 7 a.m. on your collection day.
- Waste carts are collected separately with collection times that vary throughout the day.
- Make sure carts are accessible with 3ft (1m) clearance on all sides.
- Ensure cart lids are closed to avoid litter or collection problems.
- Contaminated blue recycling carts **will not** be collected.

To prevent theft or damage to your cart; remove carts off roadways, sidewalks, back lanes etc. and return to **private property** within 24 hours of collection.

### 2020 TAX DISCOUNT & INTEREST RATES

The 2020 tax discounts and tax interest will be applied monthly at an annual rate of 1% based on the minimum balance in the account during the month. The credit will be applied to the tax account on the first business day of the following month.

Discount / Interest Rates	
*January to April	0.10 % per month
July – December	0.10 % per month

(\* The rates for January to April are a Discount Rate, which is not taxable by Revenue Canada.)

Payments and discounts will appear as a credit on the 2020 Tax Statement when issued. Payments may be made in any amount not exceeding the amount of the 2019 Tax Levy.
