

# Bylaw 4834



**A BYLAW OF THE CITY OF MEDICINE HAT** to amend Bylaw 4617, being the Vehicle for Hire Bylaw.

**WHEREAS** Council considers it advisable to amend the fees under Bylaw 4617;

**NOW THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF MEDICINE HAT, IN COUNCIL ASSEMBLED, ENACTS AS FOLLOWS:**

1. Bylaw 4617 is hereby amended as follows:
  - (a) Schedules “A” and “B” of Bylaw 4617 are repealed and replaced with Schedules “A” and “B” attached to this Bylaw.
2. This Bylaw shall come into force on January 1, 2025.
