WHEREAS the *Municipal Government Act* S.A. 1994, Chapter M-26.1 allows a council to establish a business improvement area by bylaw;

AND WHEREAS all necessary steps have been taken to establish a business improvement area named the "City Centre Development Area";

AND WHEREAS the board of the City Centre Development Area will be named the "City Centre Development Agency";

NOW THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF MEDICINE HAT IN COUNCIL ASSEMBLED ENACTS AS FOLLOWS:

TITLE

1. This Bylaw may be cited as the "City Centre Development Area" Bylaw.

DEFINITIONS

2. In this Bylaw:

- (a) "Act" means the Municipal Government Act S.A. 1994, Chapter M 26.1 and Regulations made under the Municipal Government Act.
- (b) "Agency" means the City Centre Development Agency.
- (c) "City" means the municipal corporation of the City of Medicine Hat or the area contained within the boundaries of the City of Medicine Hat, as the context requires.
- (d) "Council" means the Council of the City of Medicine Hat.

CITY CENTRE DEVELOPMENT AREA

3. The area shown outlined on Schedule "A" to this Bylaw is designated as a business improvement area.

4. The business improvement area shown on Schedule "A" is named the "City Centre Development Area".

PURPOSE

5. The purposes for which the City Centre Development Area is established are as follows:

- (a) to improve, beautify and maintain property in the City Centre Development Area;
- (b) to develop, improve and maintain public parking; and
- (c) to promote the City Centre Development Area as a business or shopping area.

CITY CENTRE DEVELOPMENT AGENCY

6. The board for the City Centre Development Area is established.

7. The name of the board is the "City Centre Development Agency".

8. (1) The Agency will consist of 11 members of whom

- (a) 10 must be individuals nominated by one or more taxpayers in the City Centre Development Area; and
- (b) 1 must be a member of Council.

(2) Members of the Agency will be appointed by Council by resolution.

9. (1) Subject to subsection (2), the term of office for members of the Agency will be as follows:

- (a) 3 years for members referred to in clause 8(1)(a); and
- (b) 1 year for a member referred to in clause 8(1)(b).

(2) The term of office for the members of the Agency referred to in clause 8(1)(a), who are appointed effective February 1, 2001, will be as follows:

- (a) 3 members will be appointed for a 1 year term;
- (b) 3 members will be appointed for a 2 year term; and
- (c) 4 members will be appointed for a 3 year term.

10. (1) Vacancies in the Agency will be filled by Council by resolution.

- (2) The term of office for a member appointed to fill a vacancy will be the unexpired term of the vacant position.
- 11. (1) The Agency may establish procedures governing the conduct of its meetings that are consistent with the provisions of the Act and this Bylaw.
- (2) The Agency may appoint such officers as it considers advisable.
