Independent Practitioner's Review Engagement Report

TO: Returning Officer City Clerk, City of Medicine Hat and Drew Barnes

Report on the Campaign Disclosure Statement and Financial Statement (Form 26)

We have reviewed the accompanying Form 26 – Campaign Disclosure Statement and Financial Statement of Drew Barnes for the calendar year ended December 31, 2025. The financial statement has been prepared in accordance with the reporting requirements of the Local Authorities Election Act (Alberta), Sections 147.3 and 147.4, and the instructions contained within Form 26 (the “applicable framework”).

Candidate's Responsibility

The candidate is responsible for the preparation and fair presentation of the financial statement in accordance with the applicable framework, including ensuring compliance with contribution and campaign expense rules under the Local Authorities Election Act. The candidate is also responsible for maintaining adequate records and supporting documentation, and for the completeness of the attached itemized campaign expense report and any required contributor listings.

Practitioner's Responsibility

Our responsibility is to express a conclusion on this financial statement based on our review. We conducted our review in accordance with CSRE 2400, Engagements to Review Historical Financial Statements, which requires us to comply with relevant ethical requirements, including independence, and to perform the review to obtain limited assurance that the financial statement is free from material misstatement.

A review engagement primarily involves making inquiries of the candidate and others involved in the campaign and performing analytical procedures, as well as additional procedures where necessary. A review is substantially less in scope than an audit and therefore does not enable us to obtain assurance that we would become aware of all significant matters that could be identified in an audit. Accordingly, we do **not** express an audit opinion.

As a result, the financial statement may not be suitable for another purpose.
