**A BYLAW OF THE CITY OF MEDICINE HAT** to amend Bylaw No. 3472, the Escort Service Bylaw.

WHEREAS it is considered desirable to amend Bylaw No. 3472.

## NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF MEDICINE HAT, IN COUNCIL ASSEMBLED, ENACTS AS FOLLOWS:

- 1. Bylaw No. 3472, the Escort Service Bylaw, is hereby amended as follows:
  - (a) The following is inserted preceding section 1:

## "PURPOSE:

The purpose of this bylaw is to establish a system of licensing for the provision of Escort service businesses ("the **Business**"), the Business activities, and persons engaged in the Business.".

(b) Subsection 2.0 (g) is repealed and replaced with the following:

""Escort" means an individual who charges or receives a fee or any other compensation for acting as a date or providing personal companionship for a limited period of time but does not include a person who provides assistance to another person because of that other person's age or ability;".

- (c) Section 7.1 is repealed and replaced with the following:
  - 7.1 Every Agency shall maintain detailed records containing the following information:
    - (a) the names, telephone or cellphone number and address of each Escort for which the Agency provided introduction services;
    - (b) dates of all introductions arranged for each Escort;
    - (c) fee charged for each introduction;
    - (d) the family name and all given names, date of birth, and the address of each client receiving services; and
    - (e) location of each introduction.
  - 7.2 A Licence Inspector or Bylaw Enforcement Officer may examine any business record or document of an Agency for the purpose of enforcing this Bylaw.".
- (e) Schedule "A" is deleted and replaced with the Schedule "A" attached hereto.

2. This Bylaw comes into force on the date that it is passed.

READ A SECOND TIME in open Council on December 16, 2024.

READ A THIRD TIME in open Council on December 16, 2024.
