



Disclaimer and Licence

City of Medicine Hat (the “City”) maintains a database of Geographic Information System data (“GIS Data”) which you are encouraged to use, subject to the following conditions:

1. By accessing and/or using the GIS Data, you acknowledge and accept the terms below.
2. The City grants you a worldwide, royalty-free, perpetual, non-exclusive license to use the GIS Data, including for commercial purposes, subject to the terms below.
3. You are free to copy, modify, publish, translate, adapt, distribute or otherwise use the GIS Data in any medium, mode or format for any lawful purpose, provided that you acknowledge the source of the information by including any attribution statement specified by the City and, where possible, provide a link to this license.
4. The terms of this licence are important, and if you fail to comply with any of them, the rights granted to you under this licence, and/or any similar licence granted by the City, will end automatically.
5. This licence does not grant you any right to use:
 - a. Personal Information (as defined in the *Protection of Privacy Act* (Alberta));
 - b. GIS Data or other records which are not accessible under applicable laws;
 - c. third party rights the City is not authorized to license;
 - d. the names crests, logos or other official symbols of the City; or
 - e. GIS Data subject to other intellectual property rights, including patents, trade-marks and official marks.
6. This licence does not grant you any right to use the GIS Data in a way that suggests any official status or that the City endorses you or your use of the GIS Data.
7. The GIS Data is provided by the City “as-is” and the City excludes all representations, warranties, obligations, and liabilities whether express or implied, to the maximum extent permitted by law.
8. Without limiting the disclaimer in paragraph 3 above, the City does not promise that GIS Data is complete, accurate, or fit to be used for any particular purpose. Before using the GIS Data, you are responsible for independently reviewing the GIS Data to confirm that it is adequate for your intended purpose.
9. The GIS Data does not constitute a field locate and is not suitable for detailed design or actual construction uses, or as the basis for hydrographic computations, estimations or analyses.
10. The City is not liable for any errors or omissions in the GIS Data and will not under any circumstances be liable for any direct, indirect, special, incidental, consequential, or other loss, injury or damage (“Claim”) caused by its use or otherwise arising in



connection with this licence or the GIS Data, even if specifically advised of the possibility of such loss, injury or damage.

11. As a condition of using the GIS Data, you agree to indemnify and save harmless the City, each and every third party supplier of any portion of the GIS Data ("Suppliers"), and their respective directors, officers, employees, agents, and/or elected officials ("Representatives") against any and all claims, costs (including reasonable solicitor client costs), damages (including any damages that are direct, consequential, or otherwise), demands, expenses, fines, liabilities, losses, obligations, penalties, or rights of action of any kind, which may be brought against the City, the Suppliers, or their Representatives in relation to your use of the GIS Data.

The City is not liable for any errors or omissions in the GIS Data, and will not under any circumstances be liable for any direct, indirect, special, incidental, consequential or other loss, injury or damage caused by its use otherwise arising in connection with this licence or the GIS Data, even if specifically advised of the possibility of such loss, injury or damage.
13. This licence is governed by the laws of the province of Alberta and the applicable laws of Canada. Legal proceedings related to this licence may only be brought in the courts of Alberta.
