A BYLAW OF THE CITY OF MEDICINE HAT to amend Bylaw No. 4027, as amended, being Schedule 'A' the River Flats Area Redevelopment Plan;

**WHEREAS** the *Municipal Government Act*, RSA 2000, Chapter M-26, empowers a municipal council to designate an area of the municipality as a redevelopment area;

**AND WHEREAS** the River Flats Area Redevelopment Plan requires the City to retain ownership of the 770 First Street SE (Lot 1, Block E, Plan 0613226) site;

**AND WHEREAS** the City is interested in potentially selling the 770 First Street SE (Lot 1, Block E, Plan 0613226) site;

**AND WHEREAS** it is necessary that the River Flats Area Redevelopment Plan be amended to exclude references to municipal ownership of the 770 First Street SE (Lot 1, Block E, Plan 0613226) site;

**AND WHEREAS** the requirements of the *Municipal Government Act*, RSA 2000, Chapter M-26 regarding the advertising of this Bylaw have been complied with;

**AND WHEREAS** copies of this Bylaw and related documents were made available for inspection by the public at the office of the City Clerk as required by the *Municipal Government Act*, RSA 2000, Chapter M-26;

**AND WHEREAS** a public hearing with respect to this Bylaw was held in the Council Chambers at City Hall on the 17<sup>th</sup> of November 2014 at 6:30 pm;

## NOW THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF MEDICINE HAT, IN COUNCIL ASSEMBLED, ENACTS AS FOLLOWS:

- 1. Schedule 'A' of Bylaw No. 4027 being the River Flats Area Redevelopment Plan, is amended by:
  - (a) Repealing Map 4 on page 19 and replacing it with Map 4 attached to this Bylaw.
  - (b) Repealing Map 5 on page 28 and replacing it with Map 5 attached to this Bylaw.
  - (c) Repealing Concept 1: Old Town Neighbourhood Plan on page 32 and replacing it with Concept 1: Old Town Neighbourhood Plan attached to this Bylaw.
  - (d) Deleting the following wording from Policy 7 on page 33: "along 1 Street SE by planning for a cultural and/or civic use at the corner of 1 Street SE and Maple Avenue and/or".
  - (e) Repealing Policy 4 in its entirety on page 85.
  - (f) Repealing Policy 2 f) in its entirety on page 88.

2. This Bylaw shall come into force at the beginning of the date that it is passed.




